Petilda Vasquez evaluates moral siege in PETROBRA'S

In agreement with the Sociologist and Researcher of the NEIM, specialist in Relation of moral Work-democracy-siege, Health and Security in the Tabalho, Petilda Vasquez, the experience of the geophysicist of PETROBRA'S in the environment of the work, Oscar Magalhães, exceeds the conception of Pain and suffering, where, complaints e the description of the case consubstanciam experiences of Moral Violence in Work.

Petilda Vasquez calls the attention that: "Brazil that of the certainty, (the example of Petrobra's), cannot be it it the cost of the psychic health, of the dignity and of the freedom of who faz. - Oscar integrates a group of sets of ten of workers who search in the Public prosecution service of the Work justice and repairing to the actual damage the state mental physicist and for the aggressions lived deeply in the cambito of PETROBRA'S

In agreement with Petilda the subject comes worrying the research institutions and proper organizations.

You already it suffered moral siege?

To be considered as responsible (it is very sensible, does not have sense of mood, it is paranóico, etc).

To be aimed at in order to seem incompetent person.

Isolation and refusal of communication - procedures sensible deeply for the victim, but banalizados for the besieger.

Discrimination to the adoecidos ones and causing an accident that returns to the work - to isolate the adoecidos ones in called rooms of "compatíveis".

It has controlled gone the doctors.

The humilhações and siege that suffer the carriers from related illnesses to the work - to suffer lying public constant and to be considered.

The decurrent upheavals of mental health of pressure in the work (CID F 43).

To have its refused and ridicularizados Findings - to deny the causal nexus - to deny medical finding, not to supply to copy of the examinations and handbooks.

Violências verbal, physical or sexual - they appear when the siege already well is declared and visible for all
